DETAILS

Following coordination with individual homeowners' associations, this asset, formerly operated as Club Wyndham Kauai Beach Villas will be offered for sale through Hilco Global. The property consists of eight, three-story buildings totaling approximately 147,000± SF and is comprised of 150 one- and two-bedroom units. The asset will be conveyed fee simple and is no longer affiliated with Club Wyndham or operated as a timeshare resort, allowing a new owner to implement a fully independent operating or redevelopment strategy. Existing unit layouts, site coverage and infrastructure support a variety of potential uses, including repositioned hospitality, extended-stay lodging, residential condominium conversion or a hybrid model subject to zoning and regulatory approvals.

LOCAL INFORMATION

Lihu'e serves as Kaua'i's primary commercial, transportation, and governmental center, anchored by the island's airport and main harbor. The area supports a mix of full-time residents, tourism activity, and essential services, making it one of the most stable submarkets on the island. Central island access allows convenient connectivity to both the North and South Shores.
